Anthony Suine, Deputy Executive Officer, Customer Services and Support (CSS), highlighted the following items: the addition of positions and workload redirection to help assist with an

increase in call volumes and wait times; slight increase in recent retirements; increase in member self-service utilization; first year adding 1099s online and the option for retirees to opt out of paper mailing; number of registrants tripled for the soon to be held California Public Employees' Retirement System (CalPERS) Benefit Education Week and used member feedback to make improvements; and a story about a struggling member receiving help getting benefits and direct deposit in the Philippines.

Don Moulds, Chief Health Director, Health Policy and Benefits Branch (HPBB), discussed the health benefits annual report for 2019, the kick off for the 2021 health plan member survey on January 11th, 2021, and the appointment of Marta Green to the Board of Directors of the Public Sector HealthCare Roundtable as well as represented CalPERS members in congressional briefings to support a federal prohibition on surprise balanced billing.

Dr. Julia Logan, Chief Medical Officer, Clinical Policy and Programs Section (CPPS), also provided a brief update on COVID-19, treatment, vaccines, and how our health plans are working to serve our members during the pandemic.

Agenda Item 6b – Risk Mitigation Strategies: Health Maintenance Organization (HMO) and Preferred Provider Organization (PPO)

Ms. Green, Chief, HPRA, presented a summary of recommendations regarding how to mitigate risk in the CalPERS HMO and PPO health plans. The proposed risk mitigation strategies do not apply to Medicare and Association health benefit plans.

On **MOTION** by Ramon Rubalcava and **SECONDED**, the Committee voted to adopt portfolio rating approach for the Basic health plan portfolio using the Milliman Advanced Risk Adjusters (MARA) prospective risk scoring tool with a two-year phase in as presented at the November meeting. This rating approach includes replacing the current PERS Basic PPO Plans with the proposed PERS Platinum and PERS Gold plans; benefit design changes will be considered next November as part of year two of a two-year phase in.

Agenda Item 6c – Minimum Standards for Health Benefit Plans – Amendment of Regulations

Ms. Green, Chief, HPRA, presented a summary of two proposed amendments to regulations: the first to update the risk adjustment sections to remove outdated procedural language that describes the previous risk adjustment process and second to delete outdated language that is inconsistent with current actuarial reserve processes.

Agenda Item 6d – Long-Term Care Optional Benefit Design and Premium Changes

Don Moulds, Chief Health Director, HPBB, presented a summary regarding adopting a rate increase for all CalPERS LTC Program policy holders of 52% no earlier than July 2021 and up to 25% no sooner than July 2022, as well as asking to approve several benefit design modifications that could be made available to LTC Program policyholders in lieu of a rate increase. Choosing one or more of those benefit design changes would be optional for policyholders.

On **MOTION** by Ramon Rubalcava and **SECONDED**, the Committee voted to 1. approve adoption of a rate increase of 52% in Year 1 and 25% in Year 2 for all CalPERS Long-Term Care Program policy holders effective July 2021, and 2. Authorize recommended benefit design

modifications that could be made available to Long-Term Care Program policyholders in lieu of a rate increase. If offered, choosing one or more of those benefit design changes would be optional for policyholders
