

Blue Shield Access+ Basic Service Area Reentry into Bay Area

8 Bay Area County Service Area Expansion

Alameda, Contra Costa, Marin, San Francisco, San Mateo, Santa Clara, Sonoma, and Solano

- Significantly benefits Bay Area subscribers
- Increases competition among health plans in the Bay Area

Blue Shield Trio Basic Service Area Expansion

Service Area Expansion

Orange, Santa Cruz, and Stanislaus

- Provides alternative HMO options for members
- Creates modest downward price pressure in the three counties

Status Updates for Board Approved Pending Proposals

UnitedHealthcare Signature Value Harmony Basic HMO

5 Southern Counties

Los Angeles, Orange, Riverside, San Bernardino, and San Diego

- Provides low-cost alternative HMO option for members
- Increases competition and causes downward price pressure in each of the counties

Western Health Advantage Basic HMO Service Area Expansion

Humboldt County

- Significantly benefits subscribers in Humboldt
- Creates the first low-cost HMO available in the county
