Agenda Item 3 – Executive Report(s)

Don Moulds, Chief Health Director, Health Policy & Benefits Branch (HPBB), shared a reminder that open enrollment runs September 20 through October 15, and highlighted the addition of lower cost HMO options and expanded Medicare Advantage plans available.

Anthony Suine, Deputy Executive Officer, Customer Services and Support (CSS), highlighted the following items: ability to hold over 5,000 phone counseling appointments monthly, 30-40 face-to-face via Webex monthly prior to a newly adapted virtual appointment scheduling system, where the number reached nearly 1,000 face-to-face sessions in the month of August; the next virtual CalPERS Benefit Education Event will be held December 8 and 9, including evening sessions on December 8; the release of our annual member statements to 1.2 million members in their online accounts; partnered with the Policy Research and Data Analytics team to analyze compensation data and identify problem areas prior to the member's retirement; enhanced review process for compensation in MOUs to improve compliance, with utilization tripling the last year from 300 to 900; an increase of 8% in retirements from January through June compared to last year; and assistance with disaster victims.

Agenda Item 6a – Proposed Regulation for the Definition of Limited Duration Employment

Ms. Renee Ostrander, Chief, Employer Account Management Division (EAMD), presented a proposed regulation necessary to clarify what is considered "limited duration" employment as stated in Government Code (GC) sections 7522.56, 21224, and 21229 for retired persons serving after retirement and section 571(a)(3) of Title 2 of the California Code of Regulations (CCR) for employees required by their employer or governing board or body to work in an upgraded position or classification. The California Public Employees' Retirement Law (PERL) and the California Public Employees' Pension Reform Act of 2013 (PEPRA) do not explicitly define "limited duration" employment for either situation. By proposing this regulation, CalPERS seeks to explicitly define "limited duration" employment and to provide clarity and uniformity for CalPERS, its members, CalPERS-covered employers, and other stakeholders by ensuring the consistent use of the term "limited duration."

The Committee requested the team work with California Department of Human Resources (CalHR) on the regulations and bring back at a future meeting.

Agenda Item 6b – Health Care Decision Support System (HCDSS) Contract Terms

Mr. David Cowling, Assistant Division Chief, Health Plan Research & Administration Division (HPRA), presented an analysis and information for consideration to extend the GEN4 HCDSS data warehouse contract term for up to one year to allow for additional novel enhancements to the GEN5 solicitation and implement a five-year contract term, with renewals of five, one-year term extensions to the GEN5 HCDSS Data Warehouse Solicitation at CalPERS' discretion.

On **MOTION** by Theresa Taylor and **SECONDED**, the Committee voted to approve 1. Extend the current HCDSS data warehouse contract (GEN4) for up to one year for CalPERS to develop potential novel requirements that may involve substantial analytical and development effort, and

2. Implement proposed contract term for the Fifth Generation (GEN5) HCDSS Data Warehouse Solicitation to a five-year contract term, with renewals of five, one-year term extensions at CalPERS' discretion.
