Agenda Item 2 – Executive Report(s)

Anthony Suine, Deputy Executive Officer, Customer Services and Support (CSS), shared his appreciation for Rob Feckner, Controller Betty Yee, and Karen Greene Ross as this was their last Board week, he also provided an update on the Contact Center's performance during open enrollment, which received one percent more calls than 2021, averaged an under eight-minute wait, and received 93% satisfaction rating from customer surveys, as well as an appreciate for all the work the team put into the Educational Forum.

Don Moulds, Chief Health Director, Health Policy & Benefits Branch (HPBB), also shared his appreciation for Rob Feckner, Controller Betty Yee, and Karen Greene Ross. Mr. Moulds gave an update on the completed health demographic profiles by our members, which have now surpassed 150,000, and after adding a technology for active employees to make changes to their health care during open enrollment, we saw a 219% increase in transactions.

Agenda Item 5a – Proposed Regulation for the Definition of Limited Duration Employment

Renee Ostrander, Division Chief, Employer Account Management Division (EAMD), presented the proposed regulation to explicitly define limited duration to allow retired persons to provide services using the skills and experience they earned over their active career, while balancing the CalPERS-covered public employers' (hereinafter referred to as employers) need for flexibility in managing their budgets and workload by utilizing those resources best suited to fit the role and the public's need for transparency and oversight to ensure post-retirement appointments that extend beyond the definition are reviewed, justified, and necessary. CalPERS also drafted this proposed regulation to explicitly define limited duration for active classic members serving in upgraded positions/classifications.

On **MOTION** by Lisa Middleton and **SECONDED** and **CARRIED**, the Committee voted to approve the revised proposed regulation to define limited duration employment with a 15-day public comment period, followed by submission of the final rulemaking package to the Office of Administrative Law (OAL) upon conclusion of the comment period, if no public comments are received.

Agenda Item 5b – Health Benefits Program Proposals for the 2024 Plan Year

Rob Jarzombek, Division Chief, Health Plan Research & Administration (HPRA), and Julia Logan, Chief Clinical Director, Clinical Policy & Programs Division (CPPD), presented a summary of select proposed 2024 benefit design changes proposaks, PPO program recommendations and future directions. The benefit design change proposals will be discussed during the November 2022 committee meeting with recommendations for action, with more coming in spring of 2023.
