Board of Administration Pension and Health Benefits Committee Draft Meeting Minutes

September 17, 2024

The Pension & Health Benefits Committee (PHBC) met in Open Session on Tuesday, September 17, 2024, in the Lincoln Plaza North Building, 400 Q Street, Sacramento, California.

The meeting was called to order at 8:31 a.m. with the following members present:

Agenda Item 6a – Health Plan Spotlight: Blue Shield and Included Health

Don Moulds, Chief Health Director, Health Policy & Benefits Branch (HPBB) provided a spotlight on Blue Shield of California and Included Health. Currently, Blue Shield administers two HMO products (Access+ and Trio) on behalf of California Public Employees' Retirement System (CalPERS). Starting in 2025, Blue Shield will administer two CalPERS Medicare Supplemental products, and Blue Shield and Included Health will administer two CalPERS Basic PPO plans. Representing Blue Shield was Paul Markovich, Chief Executive Officer and Lois Quam, President. Representing Included Health was Owen Tripp, Co-Founder and Chief Executive Officer and Dr. Ami Parekh, Chief Health Officer. Their presentations provided an overview of the plans and their key strategies, along with a discussion of how they align with our strategic goals.

At 10:58 a.m. the Committee recessed into Closed Session. The Committee reconvened into Open Session at 11:30 a.m.

Agenda Item 5a - Long Term Care Program Rates

Dr. Moulds provided a follow-up on the informational item provided to the PHBC on Prospective Long-Term Care Program Rates in June 11, 2024. This recommendation is provided within the context of promoting the Program objectives of stability and sustainability.

On **MOTION** by Theresa Taylor and **SECONDED** and **CARRIED**, the Committee voted to approve the implementation of two annual 10% rate increases for the California Public Employees' Retirement System (CalPERS) Long-Term Care (LTC Program), excluding Partnership plans. The first-rate increase would be effective in January 2025 and the second would be effective approximately one year later in 2026.

The Committee approved the implementation of three annual 6.7% rate increases for LTC Program Partnership plans beginning in 2025.

CalPERS, proposed federal and state legislation impacting the pharmacy market, and information on CalPERS current pharmacy benefit.

Dr. Moulds provided a summary of the Committee direction from the September 17, 2024, meeting. The Committee directed staff as follows:

- Upload Federal Trade Commission Report on Pharmacy Benefit Managers to the Board's shared resources.
- Make sure to have robust member communication on the Long-Term Care rate increases including policy holder buy-down options.
- Provide an update on the Aged Assured Long-Term Care program at a future Board meeting.

Agenda Item 6d – Public Comment

The Committee received Public Comment regarding Long-Term Care increases, Kaiser Senior Advantage for Monterey competition, stakeholder appreciation, and clarification of terminology on the CalPERS website related to provider in-network status.
