The Governmental Accounting Standards Board (GASB) 45 requires public agencies, including school districts and county offices of education, to report their costs and obligations for post-employment benefits, such as healthcare. The California Employers' Retiree Benefit Trust (CERBT) Program will conduct meetings at our Regional Offices and other select locations to discuss topics such as measuring and reporting Other Post Employment Benefits (OPEB) liabilities, the impact of the decision to prefund, and the CERBT, which is CalPERS OPEB trust fund for employers.
