SUBJECT: 2013/14 SCHOOL EMPLOYER POOL CONTRIBUTION RATE

The purpose of this Circular Letter is to inform you of the following employer contribution rate in respect of pension benefits that were approved by the California Public Employees' Retirement System's (CalPERS) Board of Administration on June 19, 2013. This rate becomes effective with the <u>first payroll period that ends in July 2013 and is in effect for the 2013/14 fiscal year</u>:

## EMPLOYER CONTRIBUTION AS A PERCENTAGE OF COMPENSATION

School Members

11.442%

The employer contribution rate will continue to vary annually. Member contribution rates remain unchanged for fiscal year 2013/14. School employees that meet the definition of a new member under the Public Employees' Pension Reform Act (PEPRA) will continue to contribute 6% of reportable compensation. Classic members will continue to contribute 7% of reportable compensation.
