SUBJECT: EMPLOYER INFORMATION SESSIONS:

EMPLOYER RATE STABILIZATION & GASB

The CalPERS' Board of Administration (Board) has directed Chief Actuary, Ron Seeling and Assistant Executive Officer, Ken Marzion to conduct information sessions on the topics discussed below.

The Board has approved the first reading of proposed changes to actuarial policies to help reduce volatility in employer contribution rates. The Board approved the policy changes recommended in the agenda item and gave staff direction to bring specific information regarding the implementation plans to the next meeting which is scheduled for April 19, 2005, in Sacramento. The Board also directed staff to gather additional information including employer feedback regarding pension stabilization accounts and report the findings at the same meeting.

To obtain that employer feedback before April 19, CalPERS is scheduling 5 meetings around the state to obtain your input regarding the policy changes and pension stabilization accounts. In addition to the items listed above, these meetings will also include a discussion on GASB 45, which deals with pre-funding of retiree health benefits. In particular we will talk about compliance with GASB 45, impacts on employers, impacts on CalPERS, and issues for employers and CalPERS.

We recognize this is short notice for these meetings, but believe it is very important to hear from the employers on these significant issues. This invitation to attend one of the sessions listed below is being sent to all employers who have subscribed to CalPERS "Broadcast Message System," the League of Cities List-Serve, and also through CalPERS Circular Letter process.
