TO: PUBLIC AGENCY AND SCHOOL EMPLOYERS

SUBJECT: ACTUARIAL AND HEALTH BENEFITS SEMINARS FOR EMPLOYERS

CalPERS Actuarial and Employer Services and Health Benefits Branches are teaming up this summer to present a full-day employer seminar at seven of our Regional Offices, plus Redding and Sacramento. These seminars will provide timely information about CalPERS retirement and health benefits programs and are intended for management, finance and human resources officers from public agencies and schools.

- ✓ Where can I find the information I need in CalPERS' actuarial reports?
- ✓ What will the new GASB retiree medical rules require employers to do, and when?

- ✓ CalPERS Long-Term Care Program
