**Item Name:** Proposed Decision – In the Matter of the Appeal of the Application for Disability Retirement and Earlier Effective Date of Retirement of MARY D. COLEMAN, Respondent, and CALIFORNIA DEPARTMENT OF VETERAN AFFAIRS, Respondent.

**Program:** Disability and Survivor Benefits Division

### **Parties' Positions**

Staff argues that the Board of Administration should adopt the Proposed Decision, as modified. Respondent Mary D. Coleman's (Respondent) position is included in Attachment C, if any.

### **Strategic Plan**

This item is not a specific product of either the Strategic or Annual Plans. The determination of administrative appeals is a power reserved to the Board of Administration.

### **Procedural Summary**

Respondent submitted an application for service pending disability retirement based on orthopedic conditions (left shoulder, left elbow, bilateral hands, neck, and lower back). CalPERS approved her application for service retirement, but denied her application for disability retirement. CalPERS also denied her application for an earlier effective date of retirement. Respondent appealed these determinations, and the matter was heard by the Office of Administrative Hearings on May 23, 2024. Due to California Department of Veteran Affairs' (Respondent CalVET) failure to appear, the case proceeded as a default as to Respondent CalVET only. A Proposed Decision was issued on June 19, 2024, affirming CalPERS' determination and denying the appeal.

### **Alternatives**

A. For use if the Board decides to modify and adopt the Proposed Decision as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, pursuant to Government Code section 11517, subdivision (c)(2)(C), which authorizes the Board to "make technical or other minor changes in the proposed decision," hereby modifies the Proposed Decision, by deleting "industrial" before "disability" under the Summary section on page 2; paragraphs 3 and 5 on page 3; paragraph 6 on page 4;

paragraph 42 on page 11; paragraph 46 on page 13; paragraph 1, and after paragraph 3 on page 14; before paragraph 12 on page 18; paragraph 15 on page 19; paragraph 17 on page 20; paragraph 19, and under the Order section on page 21 of the Proposed Decision, and hereby adopts as its own Decision the Proposed Decision dated June 19, 2024, as modified, concerning the appeal of Mary D. Coleman; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

B. For use if the Board decides to adopt the Proposed Decision as its own Decision:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System hereby adopts as its own Decision the Proposed Decision dated June 19, 2024, concerning the appeal of Mary D. Coleman; RESOLVED FURTHER that this Board Decision shall be effective 30 days following mailing of the Decision.

C. For use if the Board decides not to adopt the Proposed Decision, and to decide the case upon the record:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated June 19, 2024, concerning the appeal of Mary D. Coleman, hereby rejects the Proposed Decision and determines to decide the matter itself, based upon the record produced before the Administrative Law Judge and such additional evidence and arguments that are presented by the parties and accepted by the Board; RESOLVED FURTHER that the Board's Decision shall be made after notice is given to all parties.

D. For use if the Board decides to remand the matter back to the Office of Administrative Hearings for the taking of further evidence:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, after consideration of the Proposed Decision dated June 19, 2024, concerning the appeal of Mary D. Coleman, hereby rejects the Proposed Decision and refers the matter back to the Administrative Law Judge for the taking of additional evidence as specified by the Board at its meeting.

E. Precedential Nature of Decision (two alternatives; either may be used):

1. For use if the Board wants further argument on the issue of whether to designate its Decision as precedential:

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System requests the parties in the matter concerning the appeal of Mary D. Coleman, as well as interested parties, to submit written argument regarding whether the Board's Decision in this matter should be designated as precedential, and that the Board will consider the issue whether to designate its Decision as precedential at a time to be determined.

2. For use if the Board decides to designate its Decision as precedential, without further argument from the parties.

RESOLVED, that the Board of Administration of the California Public Employees' Retirement System, hereby designates as precedential its Decision concerning the appeal of Mary D. Coleman.
