	Blue Shield NetValue is available in El Dorado, Fresno, Kern, Kings, Los Angeles, Madera, Nevada, Orange, Placer, Riverside, Sacramento, San Bernardino, San Diego, San Joaquin, Santa Barbara, Ventura and Yolo Counties. Some counties will only have partial access and members should contact Blue Shield Member Services at (800) 334-5847 or <u>www.blueshieldca.com</u> to determine whether their ZIP Code is included in the NetValue service area.			
	• Blue Shield Access+			
	• Blue Shield EPO is available in Colusa, Mendocino, and Sierra counties only.			
	Kaiser Permanente			
	 PERS Select, introduced in 2008, has a smaller network of medical groups, but offers a significantly lower premium than PERS Choice or PERSCare. PERS Select is a lower cost option for members who value the freedom of choice offered through a PPO plan design. 			
	PERS Select is not available to members who live in Alameda, Marin, Placer, or Solano counties or to those who live out of state. Members should check to see if their chosen physician is participating in the Select PPO Network before seeking services. Assisting Employees with Finding a Physician or other Provider	If your employees need help finding a new Primary Care Physician (PCP) or identifying hospitals in their health plan's network, please direct them to the health plan's online physician directory or the plan's Member Services Department for assistance. Members can change their Primary Care Physician any time during the year but must choose a PCP within their health plan's network. The effective date of the change will be the first of the following month.
	• Employees who are enrolling in Blue Shield of CA or CCPOA should indicate their choice of PCP when completing the <i>Health Benefits Plan Enrollment</i> form (HBD-12). Blue Shield offers an online <i>CalPERS Personal Physician Selection</i> form.
	• Employees enrolling in Kaiser Permanente, PERS Select, PERS Choice, PERSCare, CAHP, or PORAC do not need to choose a PCP.
	Please encourage employees who are choosing a PCP to call the provider's office to verify that new patients are being accepted. Blue Shield and CCPOA will issue new member ID cards whenever members change their

The 2008 Employer Reports	CalPERS will mail employer reports on August 18, 2008. The report lists all active employees who were mailed a 2008 Health Plan Statement. The report contains the following information:
	• Agency's employer code and unit code

- Employee's first name, middle initial and last name
- Employee's address (according to CalPERS records)
- Employee's current health plan and eligibility ZIP Code

Note:

- Any address changes submitted after **June 30, 2008**, will not be reflected on this report.
- If an employee needs to update their address, the employee must complete their agency's change of address form.

Members may request Open Enrollment-related publications by using the prepaid postcard attached to the Rate Sheet. It will take approximately 10 to 12 business days for members to receive the requested materials. The pre-paid postcard expires on **September 26, 2008**.

- Your Health Plan, Your Doctors, and You: The Prescription for Quality *Health Care* (formerly the Quality Report)

Determining Your Employee's Health Plan Eligibility	ZIP Codes are used to determine the health plans in which your employees are eligible to enroll. Employees and working retirees may choose either their home or current work address ZIP Code to establish their eligibility. Retirees cannot use the address of the agency they retired from to establish their eligibility. Members and employers may use the online service, Health Plan Search by ZIP Code Web site tool to find out which health plans are available based on their ZIP Code. Refer to page 14 of this document for more information about this online service.			
Employees' Change of Address	Employees are responsible for informing their Health Benefits Officer directly of any change that will impact their health enrollment. This includes timely notification of any change to their address or telephone number. Please remind employees to report any change of address or telephone number to you in a timely manner. In addition prior to processing an address change, employers should also verify health plan availability. If the member's current health plan is not available, the member must change health plans within 60 days.			
Retiree Health Plan Changes	Retirees can change their health plan online through the following three options during Open Enrollment from September 15 through October 10, 2008:			
	• They can access my CalPERS by going to the CalPERS Web site at <u>www.calpers.ca.gov</u> . They must register first and then log in each time they visit. Once registered, they can change their health plan by selecting the " My Health Summary " link, and then choosing the " Change My Health Plan " link.			
	• Retirees may also call our Interactive Voice Response System (IVR) at 888 CalPERS (or 888 -225-7377) or,

Employees on a LOA during Open Enrollment may change plans and/or add dependents. Employees who do not change plans or add dependents during Absence (LOA) Open Enrollment may do so within 60 days from the date they return to regular pay status.

- LOA and paying direct:
 - o Employees must complete a Health Benefits Plan Enrollment form (HBD-12) and Direct Payment Authorization (HBD-21) form.
 - o For dependent changes with no change in plan code or party rate, use the HBD-12 form only.
- LOA not paying direct:
 - Employees must complete an HBD-12 form to make a plan or dependent change.

COBRA Enrollees	Enrollees who are eligible for health coverage through COBRA may change health plans and/or add eligible dependents during Open Enrollment.				
	 Enrollment changes are completed on a Group Continuation Form (HBD-85). An HBD-85 must be submitted to the Employer within 60 days of notification. Premium payments should be sent to the health plan, no CalPERS. 				
	• The effective date rules for completion of the HBD-85 form are the same as those for the HBD-12 form.				
	• COBRA rates are calculated at no more than 102 percent of the health plan's premium rate. (Please see Attachment 2 for 2009 COBRA Rates.) Under certain conditions, California law permits an extension of COBRA benefits up to 36 months. Members must coordinate CAL-COBRA with the health plan. (The CAL-COBRA extension premium cannot exceed 110 percent of the health plan premium rate.)				
Submitting Enrollment Transactions	Submit your Open Enrollment transactions as they are completed. Early submission into the Automated Communication Exchange System (ACES) will ensure timely issuance of health plan identification cards and ensure proper payroll deductions are made. NOTE: All forms submitted to CalPERS for Open Enrollment updates must be received before **October 21, 2008**, to ensure proper update into the system for the beginning of the 2009 health benefit year.

Automated Communications Exchange System (ACES) Users	All Automated Communications Exchange System (ACES) transactions must be keyed and submitted for update based on the Open Enrollment dates of September 15 through October 10, 2008. Users will have additional time after the close of the Open Enrollment period for transaction input. All Open Enrollment ACES transactions must be completed by October 21, 2008.	
Rescissions	CalPERS must receive the rescinding HBD-12 form by December 1, 2008 , to avoid payroll deduction errors. Open Enrollment rescind requests received between December 1 and December 31, 2008 will be adjusted on the February 1, 2009 payroll.	
Premium Adjustments	Despite everyone's best efforts, the January 1, 2009 , pay warrants for some members may not reflect the proper premium payment due to unavoidable processing delays during Open Enrollment. If this happens, the premium payment will be adjusted during a subsequent pay period.	
	If a member's pay warrant does not reflect their 2008 Open Enrollment health plan change, the member should <u>not</u> continue to use their prior plan <i>after</i> January 1, 2009 . Be sure the system reflects the appropriate enrollment, and advise the member that the payroll discrepancy will be resolved by the first of the next month.	
Health Plan Identification CardsHealth plans will make every effort to ensure members who char plans receive their new identification cards prior to January 1, 2 Members, who have not received identification cards for their ne should <u>not</u> continue to use their prior plan <i>after</i> January 1, 2009 should first contact the new health plan for assistance in getting r cards. If unresolved, members may then contact the CalPERS Cu Service and Education Division at 888 CalPERS (or 888-225-73) assistance.

Sequencing Transactions	If you are an ACES user, it is important to key in your transaction based on the earliest effective date.			
	 Example: An employee wants to add a newborn child effective November 1, 2008, and also make an Open Enrollment change effective January 1, 2009. 1. You must key in the newborn child first, and 2. Key in the Open Enrollment transaction the following day. If you key in the Open Enrollment transaction first, you will not be able to add the dependent, and you will need to call our ACES Hotline at 888 CalPERS (or 888-225-7377) for assistance. If you are not an ACES user, please submit the following: Two HBD-12 forms to CalPERS for processing; One HBD-12 form to add the newborn child, and One HBD-12 form for the Open Enrollment change. Staple both forms together, and in the "remarks section" number the forms as "1 of 2" and "2 of 2". 			
State Employer Contributions for Active Employees	In 2008, collective bargaining unit agreements modified State employer contributions for health care. Please refer to the Department of Personnel Administration's (DPA) Web site at <u>www.dpa.ca.gov</u> for specific allocations.			
- State Annuitant Contribution Formula for 2009 (100/90 Formula)	The 2009 State contributions for annuitants shown below are calculated based on the weighted average of the premiums for an employee or annuitant enrolled for self-alone in the Basic plan offering of the four health plans with the largest state enrollment excluding family members for the previous year. For comparison, the 2008 State contributions are also shown.

Health Plan Search by ZIP Code Web site Tool	The service area charts located in the <i>Health Program Guide</i> and the <i>Health Benefit Summary</i> indicate each health plan's general service area by county. To be eligible to enroll in a specific health plan, the employee or annuitant must live or currently work in the health plan's service area as specified in the service area chart.
	By mid-August, the Health Plan Search by ZIP Code Web site tool will be available at <u>www.calpers.ca.gov</u> . Employers with Internet access will be able to assist their employees by inputting the employee's work or home address ZIP Code and retrieving a list of health plans from which the employee can choose.
	Agencies that do not have Internet access may call CalPERS at 888 CalPERS (or 888 -225-7377) to determine whether a particular ZIP Code is included in a plan's service area and may order a hard copy of the CalPERS health plans associated ZIP Code listing.
Health Fairs	CalPERS has provided an Open Enrollment Health Fair reservation link on the CalPERS Web site at <u>www.calpers.ca.gov</u> . Employers may request a health fair with the available health plans. Once your request is submitted, the health plan will contact you to confirm your health fair.

Open Enrollment Poster	CalPERS is providing employers with a brightly colored Open Enrollment poster. The poster is approximately 17" X 20" and will be included in the boxes with your 2009 Open Enrollment publication packets that will be mailed on August 24, 2008.
	The posters can be used as a tool to assist you in reminding employees of the upcoming CalPERS Open Enrollment period. The posters include information on Open Enrollment dates as well as what members can do during the CalPERS health benefits Open Enrollment timeframe.
