TO: ALL HEALTH BENEFITS OFFICERS AND ASSISTANT HEALTH BENEFITS OFFICERS

SUBJECT: BLUE SHIELD OF CALIFORNIA NETVALUE EXIT

**Purpose** The purpose of this circular letter is to provide information to all health

benefit officers and assistant health benefit officers about the Blue Shield

NetValue exit that will be effective January 1, 2017.

**Background** 

In May 2016, the CalPERS Board approved Blue Shield's request to terminate its NetValue HMO health plan. The Blue Shield Access+ HMO health plan will continue to be available as an option to members. Most providers who participate in NetValue also participate in Access+. NetValue members who do not select another health plan during Open Enrollment will be automatically enrolled in Blue Shield Access+.

However, current NetValue members whose providers reside in a different plan and/or wish to enroll in another health plan will have the option to select another health plan during Open Enrollment.

# Member Options

During CalPERS' Open Enrollment period, **September 12 - October 7, 2016**, member(s) will have the following options:

- Take no action and CalPERS will enroll the member(s) in Blue Shield Access+ effective January 1, 2017, to ensure there is no lapse in health coverage; or,
- Select another health plan.
